#### **MINUTES**

#### of the

#### **JULY 2021 MEETING**

#### **Rotary International Board of Directors**

The Rotary International Board of Directors met virtually on 18–19 June 2021\*.

Present were: President Shekhar Mehta, President-elect Jennifer Jones, Vice President Valarie Wafer, Treasurer Virpi Honkala, Executive Committee Chair Peter Kyle, other directors, Mario César de Camargo, Jessie Harman, Susan Howe, Won-Pyo Kim, Urs Klemm, Mahesh Kotbagi, Aikaterini Kotsali-Papadimitriou, Roger Lhors, Shi-Tien Liu, Vicki Puliz, Nicki Scott, Julio César A. Silva-Santisteban, Katsuhiko Tatsuno, Elizabeth Usovicz, Ananthanarayanan S. Venkatesh, and General Secretary John Hewko. Trustee Dean Rohrs attended as Trustee liaison to the Board.

Andrew McDonald served as secretary of the meeting with assistance from Matt Hohmann. Other staff present were David Alexander, Jim Barnes, Julie Burke, Paul Haisman, Brian King, Steve Routburg, Eric Schmelling, Tom Thorfinnson, and Nora Zei. Nobuko Andrews, Alain Drouot, Marc Prevot, and Eiko Terao served as staff interpreters.

Under the guidance of the president, the general secretary had prepared an advance memorandum for this meeting containing items for consideration with background information and analyses. Those items, along with others initiated during this meeting, constituted the agenda of the meeting as reflected in the remainder of these minutes.

\* These minutes are called the "July" minutes because they are taken in the current Rotary year by the following year's Board, and do not take effect until 1 July.

#### 1. Appointment of the Vice President

Statement: RI Bylaws section 6.030. provides for the president to select a vice president from among those directors serving their second year in office.

**DECISION:** The Board notes with approval President Mehta's selection of Valarie Wafer as the 2021–22 Rotary International vice president.

#### 2. Appointment of the Treasurer

*Statement:* RI Bylaws section 6.030. provides for the president to select a treasurer from among those directors serving their second year in office.

**DECISION:** The Board notes with approval President Mehta's selection of Virpi Honkala as the 2021–22 Rotary International treasurer.

#### 3. 2022–23 Rotary Institute Site and Date Approval

Statement: As authorized by Rotary Code of Policies section 60.050., the president-elect approved the sites and dates for the 2022–23 Rotary Institutes.

**DECISION:** The Board ratifies the president-elect's selection of 2022–23 Rotary Institute sites and dates as shown in Appendix A.

#### 4. 2022–23 Nominating Committee for RI President

Statement: RI Bylaws section 10.050.2., authorizes the Board to determine the time (not later than 15 August) and place for the Nominating Committee for RI President to meet. The 2022–23 committee shall comprise 17 members from the even-numbered zones.

**DECISION:** The Board agrees that the 2022–23 Nominating Committee for RI President shall meet in Evanston, Illinois, USA, on Monday, 8 August 2022, and comprise members from the 17 even-numbered zones.

#### **5.** 2022–23 Annual Goals

Statement: The Rotary Code of Policies provides that the annual Rotary goals be approved by the Board in the year preceding the year that the goals are to be in place. President-elect Jones and Trustee Chair-elect Riseley presented a set of joint goals that align with the RI Strategic Plan and the Trustees' priorities.

**DECISION:** The Board adopts the 2022–23 joint annual goals for Rotary International and The Rotary Foundation, as shown in Appendix B.

#### 6. 2022–23 Board Meeting Dates

*Statement:* At its first meeting of the year, the Board reviews the president-elect's suggested schedule for the following year's Board meetings.

#### **DECISION:** The Board

- 1. agrees that, in addition to other virtual meetings to be held as necessary and at the discretion of the president, it shall meet during 2022–23 as follows:
  - 10 June 2022, Houston, TX, USA (directors, and spouses)
  - 11 June 2022 (Board retreat), Houston, TX, USA (directors, and spouses)
  - 18–19 August 2022 (virtual meeting)
  - 14 October 2022, joint meeting with TRF Trustees, Evanston, IL, USA (directors only)
  - 17–19 October 2022, Evanston, IL, USA (directors only)
  - 13–14 January 2023, Orlando, FL USA (directors, directors-elect, and spouses)
  - 10–12 April 2023 (virtual meeting)
  - 25 May 2023, Melbourne, Australia (directors, directors-elect, and spouses)
- 2. authorizes the 2022–23 president to adjust the above dates and sites if circumstances require.

# 7. Annual Review of Delegation of Authority to the President and General Secretary

*Statement:* At its first meeting each year, the Board reviews its delegation of authority to the president and the general secretary.

**DECISION:** The Board authorizes the president and general secretary to act on its behalf on all matters listed in Rotary Code of Policies sections 27.040. and 32.020. through 32.090.

#### 8. Policies Relating to the RI Board

*Statement:* Rotary Code of Policies section 28.005. requires the Board at its first meeting each year to review the policies governing its work.

**DECISION:** The Board affirms the policies governing its work as shown in Rotary Code of Policies section 28.005., and agrees that these policies should continue to be reviewed annually at the Board's first meeting each Rotary year.

### 9. Establishment of Districts within Zones for 2021–22

Statement: The Board annually reviews and approves the composition of the zones. Pursuant to RI Bylaws section 13.010.5., any new zone alignment can be made by the Board.

**DECISION:** The Board approves the 2021–22 zones composition as shown in Appendix C.

### 10. Selection of Zones to Nominate Directors in 2022–23

Statement: RI Bylaws section 13.010.2. requires that each zone shall nominate a director from the membership of the clubs in that zone every fourth year according to a schedule established by the Board.

**DECISION:** The Board agrees that Zones 2, 9, 13B, 17A, 21A, 25A, 28, and 33 shall select committees in 2021–22 to nominate RI directors to serve on the Board beginning 1 July 2024.

#### 11. COVID-19: Assistant Regional Coordinators

Statement: In May 2021, the Board updated its policy regarding RI-funded travel during the COVID-19 pandemic to permit certain "essential" travel. Director Lhors suggested the Board amend its policy further to permit funded travel by assistant coordinators.

#### **DECISION:** The Board

- agrees that assistant regional Rotary Foundation coordinators, assistant Rotary coordinators, and assistant Rotary public image coordinators may be funded to travel per the COVID-19 Travel Policy;
- requests regional Rotary Foundation coordinators, Rotary coordinators, and Rotary public image coordinators to consult with their assistants to determine what travel is deemed essential for their teams;
- 3. requests the general secretary to update the COVID-19 Travel Policy accordingly.

#### 12. Confirmation of 2021–22 Rotary Budget

Statement: RI Bylaws section 18.050.1. provides that the Board shall annually adopt a budget for the succeeding fiscal year. The Board customarily reviews this budget at its first meeting in the new Rotary year.

#### **DECISION:** The Board

1. confirms the fiscal year 2021–22 RI budget, reflecting

Revenues: US\$116,063,000
RI Reserve use: \$3,047,000
Convention reserve use: \$1,600,000
Expenses: \$120,104,000

Excess of revenues, reserve use, and convention reserve

over expenditure: \$606,000

2. confirms the 2021–22 RI capital expenditures budget of \$10,826,000.
